

Pesticides - Ban on active ingredients







Regulation (EC) n°1107/2009 lays down the rules governing the authorization of plant protection products in commercial form, as well as their marketing, use and control within the European Community.

Implementing regulation (EU) n°540/2011 sets out the list of active substances approved at European level.

When an active substance is not renewed, a grace period may be set. The grace period is a period granted by a Member State for the disposal, storage, placing on the market and use of stocks of plant protection products containing an active ingredient that is no longer approved at European level. Article 46 of Regulation 1107/2009 stipulates that the period of grace is limited and may not exceed 18 months.

FRANCE :

France has decided to ban all fruit and vegetables containing thiacloprid from the French market until EU MRLs have been lowered. The decree of February 23, 2024 came into force on February 25, 2024 for a period of one year (unless the EU adopts measures before then).

Article 1:

It is prohibited to import, introduce or place on the market, whether free of charge or for a consideration, fresh fruit or vegetables treated with a thiacloprid-based plant protection product and likely to contain quantifiable residues of this substance.
